Important Tax Information

The principal sources of revenue for the Township are the Real Estate Tax, the Earned Income Tax (wage tax), Local Services Tax (emergency services "\$2" tax), the Per Capita Tax (head tax), and the Deed Transfer Tax. Once residency has been established in the Township, the tax collector should be notified immediately so that your name may be added to the tax accounts.

TOWNSHIP ROAD PROGRAM PROGRESS

In 2010, the Township created a road paving program to upgrade all Township-owned roads. Each year roads, or sections of roads, are repaved.

To determine the order that roads are addressed, an annual discussion is first held between the Township Manager, Engineer, Police Chief and Public Works Foreman. Once the list is created it is presented to the Board of Supervisors for discussion and ultimate approval.

The Township allocates \$1,000,000.00 annually to cover paving and associated costs with the road paving program, and at this point nearly every Township road has been repaved.

The contract for this year's road paving program is scheduled to be on the March 20 agenda to be awarded.
